- 2. During discussion it was noticed that the following two SOE's are required to be added in the proforma as per detail given below:
  - a) The expenditure on Academic support for weak students under the activities as per table 18, 18(a) and 19 one SOE 28 is added alongwith already mentioned SOE's 11 and 34.
  - b) In the IOC (Incremental operating cost) SOE 26 was added for publicity of various courses of M.Tech, Phd, other advertisements etc.
- 3. As per the information/guidance received from NPIU from time to time, the project institutes were informed accordingly to speed up the activities related to TEQIP-II Project.
- 4. Various queries regarding procurement etc. were raised by the participants and most of them were sorted out.
