

	It was decided to collect fine for late registration by students after the due date as per following norms:	
	(i) Rs. 500/- for late registration within 07 working days.	
	(ii) Rs. 1000/- for late registration within next 07 working days.	
	(iii) Rs. 1500/- for late registration within next 07 working days.	
	(iv) Rs. 2000/- for late registration after iii (above) with the recommendations of HOD of the concerned department.	
	However, keeping in view the genuineness of the reason for late registration, the fine may be reduced or waived off by Director/Officiating Director, BCET Gurdaspur on the recommendation of Dean Academics.
